CHURCH OF GOD OF PROPHECY, NEVIS INCORPORATION ACT

AN ACT TO PROVIDE FOR THE INCORPORATION OF THE CHURCH OF GOD OF PROPHECY, NEVIS, AND TO PROVIDE FOR RELATED OR INCIDENTAL MATTERS.

Short title.

1. This Act may be cited as the Church of God of Prophecy, Nevis Incorporation Act.

Incorporation.

2. The Church of God of Prophecy, Nevis, shall be a body corporate, and shall, in its corporate name—
 - (a) have perpetual succession;
 - (b) be capable of suing and being sued in a court of law;
 - (c) have a common seal;
 - (d) be capable of acquiring property by purchase, exchange, demise or otherwise in perpetuity or for the life or lives for any term of years or upon any terms, conditions or limitations.

Vesting of property.

3. Any property that belonged, or was held in trust or on behalf of the Church of God of Prophecy, Nevis prior to the coming into force of this Act is hereby vested in the Church of God of Prophecy, Nevis, incorporated by this Act.

Power to dispose of property

4. The Church of God of Prophecy, Nevis may, subject to the regulations made under this Act, from time to time, by deed under its seal, sell or demise, grant, convey, exchange or otherwise dispose of any land or other property vested in the Church of God of Prophecy, Nevis, as it sees fit.

Saving.

5. Nothing in this Act shall affect the rights of Her Majesty, Her Heirs or successor or anybody politic or corporate or any other person except such as are mentioned in this Act and those claiming by, through, from or under them.

Regulations.

6. The Church of God of Prophecy, Nevis may, with the approval of the Minister responsible for ecclesiastic affairs, make regulations to manage its affairs.
